

**Piedmont Technical College/ Southern Wesleyan University Early Childhood
Articulation**

In order to receive transfer credit, students must do the following:

While attending Piedmont Technical College:

1. Complete the ECD and EDU courses at PTC, listed in the articulation agreement, with a grade of C or better in each course.
2. Pass all three portions of the PRAXIS I (reading, writing and math) or obtain a total score of 24 on the ACT, 1100 on the two part SAT, or 1650 on the three part SAT.
3. Maintain a cumulative GPA of 2.50 or higher to be admitted to Teacher Education at Southern Wesleyan University (SWU).
4. Meet with a SWU advisor during final semester at PTC to initiate transfer, and ensure financial aid application deadlines are adhered to.
5. Complete additional general education courses (see below) with a "C" or better, either before or after transferring.

While attending Southern Wesleyan University

1. Complete the Teacher Education admissions process.
2. Students must take courses exclusively at SWU for their last 32 hours of work and a maximum number of hours that can be transferred is 68.

General requirements or understandings of both parties:

- Credit is not granted by transfer for vocational, remedial, or developmental courses.
- Candidates will be subject to the requirements specified in the catalogs from both institutions at the date of entry into the Piedmont Technical College Early Child Development Program. If SWU catalog changes are made while completing the

first 2 years of course work, students will be allowed to use course work under the catalog year in which they began the PTC program. Transcripts are evaluated by appropriate personnel.

- The institutions reserve the right to modify requirements in accordance with the standards set forth by the Southern Association of Colleges and Schools (SACS) and the National Association for the Education of Young Children (NAEYC), the National Council for the Accreditation of Teacher Education (NCATE) and the Early Childhood Education program of SWU.

This report identifies the series of courses in the early childhood education programs which begin at the technical college and transfer directly into the SWU four-year institutional teacher certification program.


