I am in legal guardianship. Documentation: Attach a copy of the court's decision that you are or were in the custody of a legal guardian prior to the legal adult age in your state.	
I am homeless. Documentation: Attach a copy of the determination made by a school from a counselor, the school district homeless liaison or director of an emergency shelter program funded by the US Dept. of Housing and Urban Development (HUD) that you are an unaccompanied youth who is homeless.	
I am at risk of homelessness. Documentation: Attach a determination letter from the director of a runaway homeless center or transitional living program that you are an unaccompanied youth who is homeless or is se supporting <u>and</u> at risk of being homeless.	
I have a dependent(s) other than my own children or spouse who receive more than half of their support from me. Documentation: Attach legal documentation of their relationship to you such as a birth certificate, legal guardianship, etc. or any receipts to substantiate your claim of support to the dependent(s).
