

# **Emergency Medical Technician - Program Fact Sheet**

#### **Program Location and Duration**

- Greenwood Campus
- One (1) semester

#### **Program Entrance Requirements**

- This is a direct admit program. There is no secondary application process in place for this major.
- Courses are offered on a first-come, first -served basis.

#### **Financial Aid Considerations**

- This program is not eligible for Title IV (Federal) financial aid funding. Eligible students may receive Lottery Tuition Assistance (LTA).
- FAFSA is not required. The FAFSA waiver may be submitted for LTA only.
- Additional Financial assistance may be available for qualified applicants.

# **Program Enrollment**

Program enrollment is limited; therefore, all Additional Requirements (see information to the right) must be completed by the first day of class.

# Additional Requirements:

- COMPLETED background check https://catch.sled.sc.gov/.
- 10 panel drug screening
- Immunization record for the following:
  - 2 MMR (measles, mumps and rubella)
  - o 3 Hepatitis B
  - 2 Varicella (or positive titer or documentation of history of chickenpox)
  - Tetanus (within the past 10 years)
  - PPD (2-step tuberculosis test)
  - Flu shot (from current Flu season)
  - COVID-19\*\*
- Be prepared to pay a fee for Castlebranch Document Management System.
- Laptop and/or desktop with reliable internet access and access PTC Pathway, Webex & ZOOM webcam and mic.
- PTC student ID and parking decal-order through PTC Pathway
- Textbooks for the course
- Uniform: Two pair of navy tactical pants and 2 grey polos, black closed-toe safety shoes, black belt
- BP cuff and stethoscope
  - \*\* Required by many internship sites. Instructor will provide further information on internship sites' COVID vaccination requirements.

Immunizations can be received from the Greenwood Health Dept., Publix, your family doctor or your local physician's care office.
